Due to Covid-19 Pandemic, the University inspection for MBBS Degree Course with an annual intake of 150 seats could not be conducted & based on the Resolution No.4(I), passed at the 277th Governing Council meeting held on 30.09.2020, the Managing Trustee of Vinayaka Mission's Research Foundation Trust has submitted a notarized affidavit duly signed to abide by the appropriate rules regarding non conduct of regular inspection for the academic year 2020-2021.
