In the reference 1st cited, Vinayaka Missions Research Foundation Trust, Sankari Main Road (NH-47), Ariyanoor, Salem – 636 308 has obtained Government Order from Health and Family Welfare Department, Secretariat, Chennai, Tamil Nadu for the purpose of establishing a new Medical College in the name and style of Annapoorana Medical College & Hospital, Sankari Main Road (NH-47), Veerapandi Union, Salem - 636 308 to conduct M.B.B.S. Degree Course with an annual intake of 150 seats for the academic year 2008-2009.

2. In the reference 2nd cited, this University has granted Provisional Affiliation orders to Annapoorana Medical College & Hospital, Salem for the starting of MBBS Degree Course with an annual intake of 150 students from the academic year 2011-2012, as per the approval granted by the Medical Council of India.

3. In the reference 3rd cited, this University has granted Provisional Affiliation orders to Annapoorana Medical College & Hospital, Salem for starting of Five (05) new Specialities in M.D. Broad Speciality Degree Course with an annual intake mentioned against each for academic year 2022-2023.
